At all times, I will adhere to Denver Municipal Airport System Rules and Regulations, Part 20 (available at <http://www.flydenver.com> or at Airport Security Badging Offices). I understand, acknowledge, and agree that violations of the Critical Violations "Big 6" (Section 20.04-16) may result in immediate revocation of my Airport ID badge and that I am personally responsible for all TSA imposed Civil Penalties incurred by myself. I understand that if accessing or controlling an access point (doors, gates, etc.), I must challenge and request Airport approved identification from all individuals who attempt to gain access to assure that they are authorized. When accessing or controlling an access point, I shall not permit an individual to gain access unless the individual successfully uses their Airport ID badge. If my badge has Driver Authorization, I agree to abide by all Rules and Regulations for the operation of a vehicle within the Secured Area, and understand that failure to do so may result in revocation of my driving privileges. Airport personnel are not authorized to enter runways or taxiways unless they are escorted by, or it has been authorized by, Airport Operations.
